DESCRIPTION The Old School House is a charming detached period property which has recently been refurbished throughout. The beautifully appointed and well presented accommodation extends to around 2101 sq. ft, and is arranged over two floors comprising of a well proportioned drawing room with a dual aspect and large wood burner. There is also a second reception/dining room, again with a wood burner leading to a spacious kitchen and breakfast room with wooden worktops and an Aga.

There is also a useful utility room, providing space for household appliances, a downstairs shower/WC plus a lovely, light study with French

doors leading to a south facing patio.

On the first floor is an impressive master suite, with en-suite bathroom and dressing area, plus two further double bedrooms, a single bedroom and family bathroom.

Externally, the property has a gated driveway with parking for several cars and a large, mature garden mainly laid to lawn with bushes and fruit trees scattered throughout.






## Old School House, Ashley, Tetbury


Internal area 2,101 sq ft (195 sq m)
